



2010 CEP SHOW SERIES VENDOR INFORMATION

TERMS AND CONDITIONS

Our policy is to accept vendors as space and electrical requirements permit, while limiting the number of vendors with similar wares or services. Priority will be given to vendors who regularly attend CEP shows throughout the year. CEP reserves the right to reject any application for any reason whatsoever. In the event that your application is not accepted, your deposit will be fully refunded. Deposit of an applicant's check does not mean acceptance of vendor's application.

If your application is approved and you subsequently satisfy the requirements set forth below, your deposit will be treated as a non-refundable deposit to be applied to the total amount due to CEP. Please be advised that the acceptance of your application does not constitute a contract with CEP until each of the following two requirements are met: 1) CEP notifies you in writing or via email that you have been accepted as a vendor, and 2) you satisfactorily provide copies of the requisite insurance certificates and business licenses set forth below.

If your Vendor Application is approved, you will be required to provide CEP with a copy of each of the following:

Scottsdale Transaction Privilege Tax License - vendors at Westworld are required to have this license - contact Tom Borin, City of Scottsdale Tax Bureau, at (480) 312-2400 or email at tborin@scottsdaleaz.gov to obtain one.

Liability Insurance Coverage - a certificate of insurance evidencing a policy of One Million Dollars (\$1,000,000) per occurrence in Combined Single Limit Bodily Injury and Property Damage insurance, naming the following parties as additional insureds: Collman Equestrian Productions, Inc.; City Of Scottsdale; and Bureau of Reclamation. Such insurance policy shall not contain an athletic performance exclusion.

Failure to satisfy these requirements prior to your arrival will preclude you from entering into a contract with CEP irrespective of the fact that your application was accepted and will result in the forfeiture of your deposit.

Vendor Fees - are \$25 per show day per 100 square feet of space used or any portion thereof. Your total space used is measured, including any display racks, awnings or areas adjacent to your actual set-up. Vehicles, trailers, tents and canopies are all permitted and are the responsibility of each individual vendor. Westworld policies require payment for all show days, regardless of the number of days you are actually open for business (for example, if you have an 8'x30' trailer, a total of 240 square feet, and are attending a four day show, your total vendor fee would be \$300, regardless of how many days you were set-up and actually open for business). All vendors must confirm details and locations with show management prior to parking any rigs or installing any tents or canopies. Limited electricity is included if requested.

STEPS

- 1) Submit completed application and a check for the \$50 deposit (payable to CEP), which must be received not later than 14 days prior to the first day of the show (incomplete applications or applications submitted without deposit will be discarded; deposits received less than 14 days before the start of the show will be forfeited as a late fee)
- 2) If application is accepted, vendor must submit to CEP the requisite insurance certificates and business licenses not later than seven (7) days prior to the start of the show
- 3) An open check must be left in the horse show office upon arrival prior to set-up.
